**A. NRCS Report:** Jenna Dunn's report for Lihue Field Office November/December 2018:

**1. General**

- Maui DC- Candidate who was selected decided not to take the position. Effective 11/24 Kauai DC will act as DC for Kahului office until position is filled.
- Waimea DC- Interviews have occurred. No selection announced yet.
- Area Resource Conservationist (ARC)- Morri-Ann Nagata has been selected.
- Cultural Resource Specialist- Position has been advertised, no selection announced yet.
- Assistant Director for Programs- will be vacant on 1/5/2019. Position has not been advertised yet.

**2. Farm Bill Programs**

- EQIP FY19- Sign up deadline will be 12/21/2019. Kauai currently has approximately 34 applications.

**3. Office related**

- If a client only needs brief technical assistance and no permit exemption and is not signing up for programs, we will provide assistance but not a full conservation plan.
